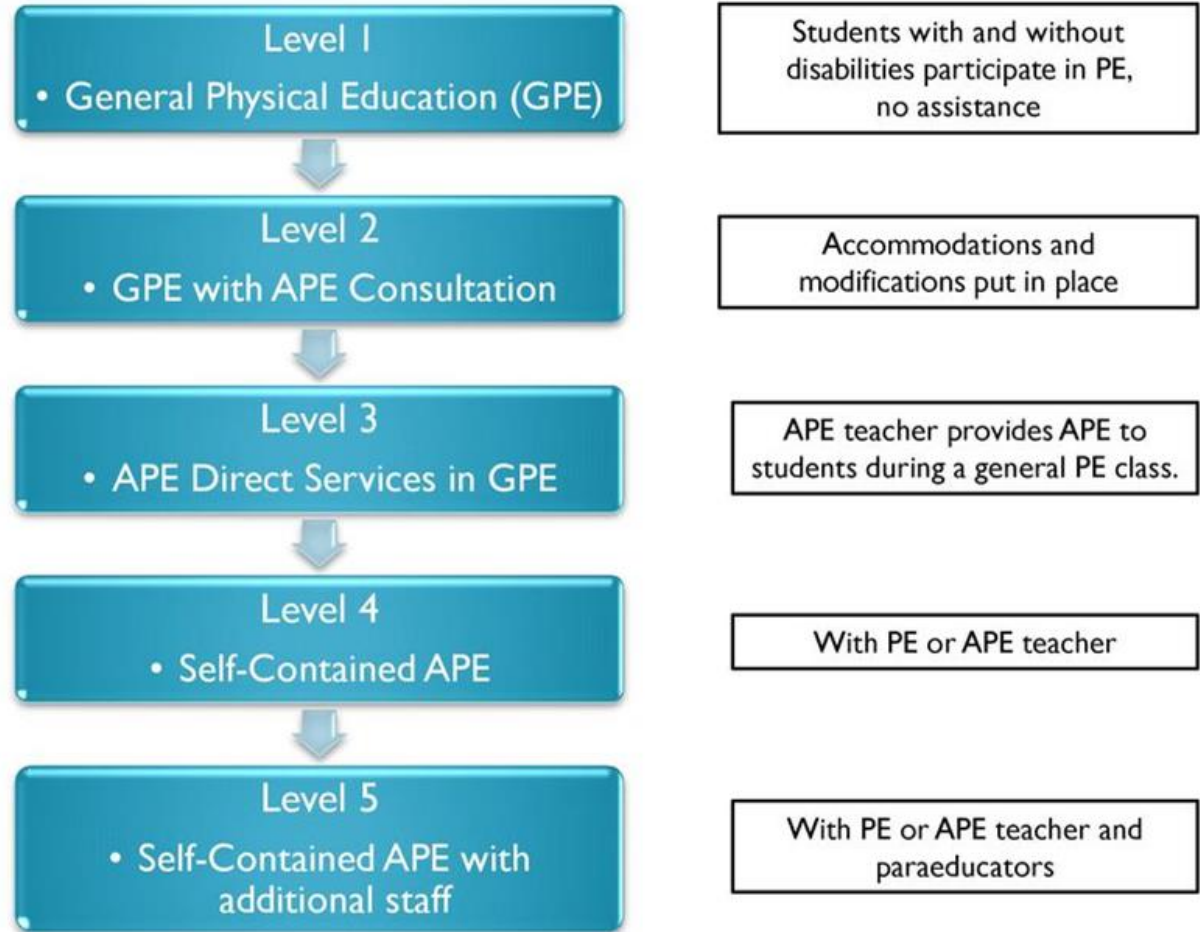

Multiple Means of Representation

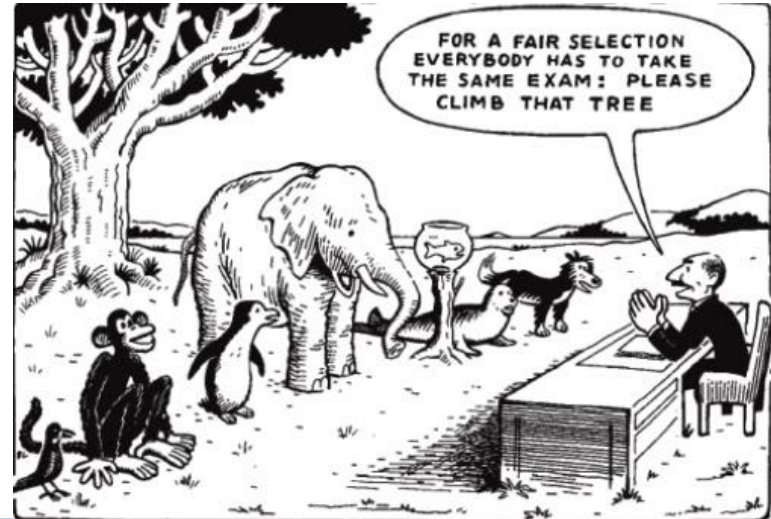
Gives learners various ways of acquiring information and knowledge

Multiple Means of Engagement

Taps into learners' interests, challenges them appropriately, and motivates them to learn

Multiple Means of Expression

Provides learners alternatives for demonstrating what they know

- Peer-adapted physical education observation
- Peer coaching
- Curriculum development
- Collaborative action research

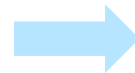

- Enhance leadership and effective school or school district management

- School or school district atmosphere and culture
- School or school district organizational knowledge or assets
